Permadi Arya or Abu Janda reported to Bareskrim National Police by the Indonesian Youth National Committee (KNPI) on January 28, 2021, on guess speech racism in his tweets against ex-commissioner Komnas HAM Natalius Pigai and SARA against religion. Abu Janda write on account Twitter @permadiaktivis1: "Kapasitas Jenderal Hendropriyono: Mantan Kepala BIN, Mantan Direktur Bais, Mantan Menteri Transmigrasi, Profesor Filsafat Ilmu Intelijen, Berjasa di berbagai Operasi Militer. Kau @NataliusPigai2 apa kapasitas kau?". According to Chairman KNPI Media Field of Law Risza Lubis, Abu Janda has very clearly spread speech hatred through the word "evolution" it uses and aims to insult shape physique from a group of the same ethnicity with Natalius Pigai.

From the case, they appear to have occurred a very significant shift in life's social and cultural public moment. Users are often not enough wise about the media social and even abuse it. instead, put forward an opinion or comment on one content, happened precisely throw words that contain elements of demeaning, insulting, or hatred to party another.
