This policy makes teaching and learning activities in the context of face-to-face that are usually carried out in schools temporarily suspended. The government is replacing learning with an online learning system through existing online learning applications. With this policy, online learning that was previously not optimally applied is the only choice of learning forms.

Learning must continue, despite the global pandemic disaster that made the government apply social distancing to the world of education. The most appropriate solution with this pandemic is online learning. Online learning is basically learning that is done virtually hammering the virtual applications available. Teachers can also do learning together at the same time using groups on social media such as Whatsapp (WA), Telegram, Instagram, Zoom application or other media as learning media. With it the teacher can ensure students follow the learning at the same time, even in different places.

The online learning model is the teacher's preferred learning model or pattern to plan the appropriate and efficient learning process to achieve learning goals by utilizing computer networks and the internet (Yanti et al., 2020, p.56). This learning is less effective because there are still some students / parents of students do not have mobile phones and internet signal constraints.

The duration of time given by teachers to these students during online learning is quite different. Some are 3 hours long with a break for a break of 30 minutes, some are

conditional according to the student's condition and also not burdensome to students, and some are 2 hours given a break time also for 30 minutes.

Teachers provide materials during online learning using animated videos that are in accordance with the material provided by the teacher and also in the form of Power Points (PPT) containing materials that are in accordance with online learning. During online learning, teachers are not too demanding to give assignments to students, it's just given practice questions that are in accordance with the material. And there is also one teacher who gives assignments to students by being given 1 week to do the task. After 1 week the task is completed, parents come to the school to collect the task to be given grades by the teacher.

The media used during online learning starting from Zoom, Google Meet, has been done well. But sometimes constrained by students' internet signals. And also use Google Form to do tasks given by teachers and to do them still assisted by parents at home as supervision of children during online learning.

As for the way to grow students' learning interest, it is to provide interesting animated videos so that students are interested in ongoing learning. And in online learning also conveys the motivation to learn and the spirit to learn even though greeting only virtually. Teachers always provide motivation to students when online learning takes place so that students are not saturated, not weak, and students' learning interest remains. And also pay attention to students as they should like in class. If the student does not know or understand about the material as a teacher helps students in experiencing difficulties so that students understand the material that has been given by the teacher.

This online learning affects students' learning interests due to learning that is different from classroom learning. Students' learning interest can drop because the video provided is less interesting. If the learning is classed if the student's interest in learning has dropped and is not excited anymore, usually the teacher gives a game or sings together. And it can also be the application of learning in the class that can be applied in online learning although not every day so that students are not easily bored in the online learning process.
